

By an agreement with the Republic of South Africa dated 29th June 1910, Swaziland is dealt with for Customs purposes as a part of the Republic, and a fixed percentage of the total collections in the Republic is paid to the Territory annually. Payments are assessed on the proportion which the average amount of the collections of the Territory for the three years ended 31st March 1911, bore to the average amount of the Customs revenue of the Republic during the same period.

2. The imports consist principally of maize, groceries, wearing apparel, kaffir truck, hardware, machinery, building materials, petrol, oil, etc., most of which are imported from the Republic of South Africa from importers established there. Except for a few items, mainly articles of food and household requirements, prices are not controlled.

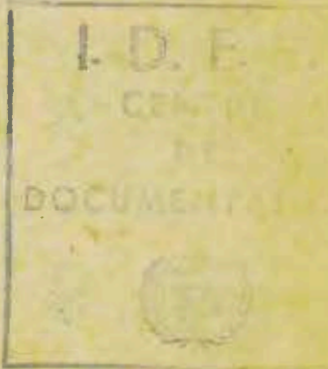
